

**MEDICAL EXPENSE REIMBURSEMENT PLAN OF THE
CALIFORNIA FIREFIGHTERS BENEFIT TRUST**

SUMMARY ANNUAL REPORT

This is a summary of the annual report for the Medical Expense Reimbursement Plan of the California Firefighters Benefit Trust (Employer Identification No. 33-0581737, Plan No. 501, formerly the Southern California Firefighters Benefit Trust) for the year ended February 28, 2021. The annual report has been filed with the Department of Labor's Employee Benefits Security Administration as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Health, dental, and vision insurance premiums, long term care insurance premium, and qualified medical expenses reimbursement benefits for retired participants, as defined by the Plan document and the Trust agreement, are provided by contractual contributions from the participants and the participating employers.

BASIC FINANCIAL STATEMENTS

The net assets of the Plan, after subtracting liabilities, totaled \$63,415,959 at the end of the year compared to \$50,531,802 at the beginning of the year. During the period, the Plan experienced an increase in net assets of \$12,884,157. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of assets at the end of year and the value of assets at the beginning of the year or the cost of assets acquired during the year.

The Plan's gross income was \$14,299,956 of which contributions from employers were \$4,023,578, contributions from participants were \$2,777,140, contribution from association were \$64,150, and investment income was \$7,435,088. The Plan expenses were \$1,415,799. These expenses included \$1,047,982 of benefits paid to participants and beneficiaries, \$53,745 of investment advisors fees, and \$314,072 of administrative expenses.

If you request a copy of the full annual report from the Plan contract administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
